No member of our CCV community may single out anyone and harass (sexually or otherwise) or discriminate against him/her/them on the basis of their belonging (or being perceived as belonging) to a protected group.

Sexual misconduct is prohibited and will not be tolerated at Community College of Vermont. Sexual misconduct includes, but is not limited to, sexual activity or sexual touching without the consent of the other person, sexual assault, domestic violence, dating violence, and stalking where the conduct is based on the sex/gender of the victim. If you are a victim of sexual misconduct, get to a safe place and call the statewide hotline at 1-800-489-7273. If you are a victim of domestic violence, call the statewide hotline at 1-800-228-7395.

If you are subject to, observe or suspect sexual misconduct, harassment, discrimination, or violence, it is vitally important for you to bring it to the attention of a CCV staff member.
