These instructors had no online teaching experience at CCV prior to March 2020 and it was a significant disruption as each had to learn the

During this period, faculty and staff were diverted from their regular work in order to support the transition to, and support of, remote instruction. This work included installing and maintaining new software, training and supporting instructors and students, redesigning classes for remote or hybrid instruction, and increasing opportunities for faculty training. For these specific staff, meetings are conducted via Zoom or phone, helping guide the supervision model of staff and faculty and helping them to be well versed in online course management. CCV did not reduce the number of employees due to COVID-19, but retained all of its employees.
