I'd like to reassure you that President's Council is closely monitoring the situation and share what we can all do to in response to this emerging public health threat.

- Per the Center for Disease Control, we are reminding everyone to stay home if you have any
 symptoms of acute respiratory illness (such as fever, coughing, or shortness of breath). If you
 have a fever, stay home until your temperature has stayed below 100.4 degrees for 24 hours
 without the help of fever-reducing medicine.
- It is important that you immediately alert your supervisor if you or someone you have had close contact with has a confirmed case of COVID-19 or is being monitored for the Coronavirus.
- Coordinators, please inform your regional director if a student or faculty informs you:
 - o they have a suspected or confirmed case of COVID-19
 - they are in close contact with a confirmed case of COVID-19
 - o they are in close contact with someone who is being monitored for the virus

We will be sending an email to faculty on Wednesday morning that will include tips and resources for moving a class online as well as how to access one on one support for making this transition should it become necessary. We will also be sending a message to students which includes resources for Canvas support for students should classes need to be completed online.

To keep you updated, we have created a <u>webpage</u> that has the most recent information on COVID-19's impact on CCV communities, a repository of Coronavirus-related communication, and FAQs.

Finally, we are taking important steps to reduce the possibility of community exposure and transference of the virus. For the remainder of March through April 3, we are asking that you:

CCV leadership, in partnership with the Vermont Department of Health, have been closely monitoring the ongoing developments with the COVID-19/Coronavirus.

Our priority throughout this evolving situation is the health and safety of our students, faculty, and staff.

In response to this situation, CCV has made the following decisions about our plan moving forward:

- 1. Online classes at CCV will continue without interruption.
- 2. All on-ground classes that meet at CCV centers will move online beginning Monday, March 23rd through the remainder of the spring semester.
 - On-ground classes that meet at CCV centers will not meet during the week of March 16-20.
 - Students will use this time as a study week, and faculty will use the time to transition their classes to an online environment.
 - All spring classes will follow the established academic calendar, ending on the scheduled date.
- 3. CCV academic centers will remain open. Students and faculty are welcome to access our services and resources and will be able to utilize computer labs.
- 4. We have increased the rigor of cleaning in our centers by disinfecting common surfaces inside our classrooms and facilities more frequently and will continue to do so.

Students: We know that this causes disruptions to your learning and adds stress to your already busy lives. Please know that the College is here to support you throughout this process. CCV staff will be available in person, by phone, or by email to help you access the resources you need to be academically successful in an online environment. Please reach out to your advisor or local center. You are encouraged to use the resources that Dean of Student Affairs Heather Weinstein provided in her March 9 email.

Faculty: I want to acknowledge the work that transitioning to a completely online environment entails. While many of you currently teach in an online platform or regularly use Canvas in your classes, others will need additional support. Please reach out to your Coordinator of Teaching and Learning. We will also be running Zoom sessions and developing additional support for faculty throughout this time period. In addition, please use the resources that Academic Dean Debby Stewart provided in her March 11 email.. These resources will also be archived on Teach at CCV and on our public website.

Staff: Thank you for your patience and flexibility during this volatile time. CCV academic centers will remain open with normal operating hours. If you have questions or concerns, please talk with your supervisor. Regional directors/supervisors will be meeting with all staff throughout this transition to ensure you have the resources you need to answer any questions that arise.

We will continue to be vigilant in the practices we have implemented this week:

Communications:

- Senior leadership continues to meet daily about this evolving situation.

• We are communicating with students, faculty, and staff via email to keep our community aware of updates and planning.

In CCV centers, we are:

- Implementing protocols for social distancing.
- Increasing awareness about germ avoidance and good personal hygiene.

- Increasing the rigor of cleaning in our centers by disinfecting common surfaces inside our classrooms and facilities more frequently.
- Making hand sanitizer and disinfecting wipes available.
- Updating protocols for cleaning of our computer labs.

CCV is Ready to Help Rebuild Vermont Joyce Judy, CCV President

The Vermont State Colleges System is weathering the roughest days of its 60-year history. The potential changes facing our sister institutions are painful and the challenges are real. While the Community College of Vermont (CCV) is not immune to these challenges, we are fundamentally unique, financially stable, and poised to help rebuild Vermont in the wake of COVID-19.

With our statewide presence and unyielding commitment to access, CCV is the second-largest college in Vermont. We serve more than 10,000 students each year at 12 locations and online. Those students go on to bachelor's degree programs throughout the VSC, at UVM, and beyond, and into high-demand jobs that grow Vermont's economy.

When CCV was founded in 1970, we were seen as a bold experiment. Rather than asking rural Vermont to come to a college campus, CCV would bring college to rural Vermont. In other words, we would meet students where they were. This concept is at the core of our work. We meet students where they are, not just geographically, but also financially, academically, and as individuals. As we respond to the disruptions caused by COVID-19, we will maintain focus on this idea. We are here to help Vermonters get back on their feet.

CCV has always been adaptive, resilient, and relevant. We pioneered online learning in Vermont nearly 25 years ago, and today we offer hundreds of online courses each semester. CCV's decentralized, non-residential model means that 95% of Vermont households are within 25 miles of a CCV classroom. We provide students with resources in their local communities. Our suite of online options draws from the best of both worlds: one-on-one, local advising paired with a high-quality academic experience. We help students who are new to online learning achieve success.

Despite minimal state support over the past three decades, CCV continues to offer the most affordable tuition in Vermont. 65% of our students graduate with zero debt. We have long championed the idea that education beyond high school is a necessity for all, not a privilege for some. In as little as one semester, students can earn valuable credentials at CCV that translate to higher wages and greater stability. We will continue to work with partners and employers across the state to meet developing needs in response to COVID-19.

As we prepare to re-open and rebuild our economy, CCV is ready with the education and training Vermonters will need. Our statewide presence means that we are deeply rooted in Vermont's communities. Subject: Student Rights & Responsibilities and Mandatory Guidelines to Support Community Health

It is my privilege to serve as your dean of students. An important part of my role is to work with my colleagues to provide a respectful, safe, and professional environment for all members of the CCV community. To that end, this notice is to inform all students about their rights and responsibilities as members of the Community College of Vermont community. As CCV community members, all students are expected to review and comply with CCV and Vermont State College System (VSCS) policies.

As we begin this fall semester, I'd like to highlight some of the important procedures in place to support the health of the CCV community. Please do your part in following these guidelines.

CCV center access this fall will only be available to faculty and students who are either participating in the on-ground portion of a hybrid class or—by appointment only—for computer lab usage.

All students must sign the CCV Student Health Contract prior to accessing a CCV center.

Any person accessing a CCV center is obligated to comply with <u>CCV's Procedures for Accessing CCV Centers in Fall 2020</u> and the <u>Student Health Contract</u>. Failure to comply will be in violation of the <u>Student Code of Conduct</u>.

Students who would like to request disability accommodations and/or alternative methods for meeting safety standards should contact an <u>accessibility coordinator</u>.

Below are the detailed links to the College's formal COVID plans. These plans include the specific steps we are taking to keep the CCV community healthy and will be updated as needed. They are available on our COVID-19 public webpage and are being shared with all staff and faculty in addition to being shared with you. Dear CCV community,

Regrettably, today we learned that a member of our CCV-Winooski learning community has tested positive for COVID-19.

Upon learning of the result, we consulted Vermont Department of Health (DoH). The DoH is responsible for contact tracing and will notify anyone who needs to be informed. Based on the information available, the DoH does *not* believe this person was infectious when they attended class early last week.

At this time, there is no identified elevated risk for our community.

I recognize that this message brings unsettling news during a stressful time. I want to assure you that CCV is following our <u>established procedures</u> and the guidance provided by the Department of Health. I'm proud of the cooperation CCV students and employees have demonstrated during these past few months, maintaining vigilance and adhering to our protocols to keep each other safe. Please continue to do your part to support the health and safety of those in our academic centers and surrounding communities by following these guidelines:

Wear a mask.
Stay at least six feet from others.
Wash your hands often.
Stay home if you are experiencing any COVID symptoms.

Dear CCV Faculty,

I am writing with an important update on the College's COVID-19 guidelines and plan for reopening our academic centers. We have and will continue to follow the guidance provided to us by State officials and the Center for Disease Control, including encouraging all CCV community members to get vaccinated if able. This is the way we support each other.

- Beginning July 1, staff will transition back to their offices. Centers will remain closed to
 the general public, but faculty and students will no longer need to make an appointment
 to stop by the center. For example, faculty can make photocopies, collect their mail, or
 meet with a staff member.
- Beginning August 16, the majority of staff will be working regularly from their offices.
 Centers will remain open for faculty and students, but will also be open for visitors.

In addition to the timeline above, I want to make you aware of the College's updated guidelines around vaccination and masking and answer any questions you may have.

- Will students be required to be vaccinated? Not at this time. As a non-residential college, we do *not* require proof of vaccination except in certain state-mandated programs, and we will continue that practice.
- Am I required to be vaccinated? Not at this time.
- Can I ask if someone is vaccinated? You may ask if someone is vaccinated but you
 may not ask to see their proof of vaccination or demand to know why they are not
 vaccinated. Furthermore, it is important to remember there are many reasons why
 someone may not be vaccinated.
- Can I require that someone wear a mask in my presence? No. You may wear a mask at any time, particularly if you're uncomfortable, but you may not require others to do so.
- Will social distancing remain in effect for my class? As the State adjusts its guidance on social distancing, so too will CCV. We anticipate this may happen soon.
- I have accepted an assignment to teach in person in the fall. If I no longer feel comfortable with that arrangement, what do I do? Contact your CTL as soon as possible.

If you have additional questions, feel free to contact your CTL or me. We will also be updating the COVID-19 page on CCV's public <u>website</u>; you can always check there for the latest information. In addition, we will continue to monitor the guidance provided by State officials and the CDC, and will adjust CCV guidance accordingly.

We have much to be proud of over the past 14 months. Our community has worked hard to meet the challenges in front of us. I am so grateful for your efforts—from learning all you could about new technological and pedagogical tools to thinking about additional ways to support your students. Your efforts have made a difference.

Hello CCV students,

The College is looking forward to fully re-opening and welcoming you back to its academic centers. Beginning July 1, CCV centers will be open to all students and faculty, with some inperson advising opportunities available.

Vermonters have many reasons to be proud. Throughout this pandemic, Vermont's safety guidelines and low infection rates have been a model for the nation. Vermont has achieved the highest COVID-19 vaccination rate in the country, with 80% of Vermonters vaccinated against the virus. One of the most important steps we all can take to keep ourselves, loved ones, and community members safe is to get the COVID-19 vaccination as soon as possible. Vaccines are highly effective in preventing death and hospitalization and will protect you from getting sick. There is no cost to get the vaccine which is <u>available in many pharmacies and walk-in clinics</u> around the state.

CCV remains committed to providing a healthy learning environment and will continue to follow the most current state guidance and CDC safety protocols. We'd like to provide anticipated health protocols for the fall semester.

Will students be required to be vaccinated?

Not at this time. As a non-residential college, CCV does **not** require proof of vaccinations except in certain state-mandated programs. CCV will continue to follow Vermont guidelines, including encouraging all CCV community members to get vaccinated, if able. Vaccination continues to be the most effective way to protect ourselves and each other against the virus.

Will students be required to wear masks in academic centers?

Per the Center for Disease Control (CDC), "Mask use is recommended for people who are not fully vaccinated."

Can I ask if someone is vaccinated?

You may ask if someone is vaccinated but you may **not** ask to see their proof of vaccination or ask why they are not vaccinated. Furthermore, it is important to remember there are many reasons why someone may not be vaccinated.

Will social distancing remain in effect when I am in CCV centers?

As the State adjusts its guidance on social distancing, so too will CCV. We anticipate state officials will release new guidelines soon.

The College will continue to monitor the guidance provided by state officials and the CDC and will adjust its protocols accordingly. I will keep you updated if new guidance emerges. Additionally, CCV will continue to update the COVID-19 page on its public website.

If you are teaching an in-person summer class that will be meeting on August 9th or after, you and your students will need to be masked. Please post this announcement in your Canvas classroom. In addition, all CCV facilities will have signage in place and masks available.

I have also included some common questions and answers below:

- I teach an online class. Are masks required if I stop by the center to pick up a textbook or other mail? Yes. Masks will be required for anyone who enters a CCV facility for any reason starting on August 9th.
- I am scheduled to teach an in-person class in the fall. Will masking be required then? Most likely, yes. We will re-evaluate this practice on a regular basis, and let you know if there are any changes, but we do not anticipate changes happening before the start of the fall semester.
- Will there be social distancing in my on-ground class? No, the Governor's Office has not recommended distancing.
- I am scheduled to teach an in-person class in the fall. What do I do if a student alerts me right before class that they are sick with COVID symptoms or have been exposed to someone who tested positive for COVID? Let your student know that they should not come to class. Signage at CCV entrances will instruct anyone who is experiencing cough, fever, or shortness of breath to refrain from entering the building. Encourage students to talk with their advisor and contact your coordinator of teaching and learning (CTL) to let them know about the situation.
- What do I do if a student says that they have a condition that prevents them from having to wear a mask? Refer your student to an <u>accessibility coordinator</u>.

I am enrolled in an in-person class in the fall. Will masking be required then? Most likely, yes. We will re-evaluate this practice on a regular basis, and let you know if there are any changes, but we do not anticipate changes happening before the start of the fall semester.

Will there be social distancing in my on-ground class?

No, the Governor's Office has not recommended distancing.

What if I have a medical condition that prevents me from having to wear a mask? Students who would like to request disability accommodations and/or alternative methods for meeting safety standards should contact an <u>accessibility coordinator</u>.

Will students be required to be vaccinated?

Vaccination continues to be the most effective way to protect ourselves and each other against the virus. It is our expectation that everyone in our learning community will be vaccinated if they are able to do so. However, as a non-residential college, we do *not* currently require proof of vaccination except in certain state-mandated programs, and at this time, we will continue that practice.

What should I do if I test positive for COVID, have COVID symptoms, or have been exposed to someone who tested positive for COVID?

Do not come to class or enter a CCV academic center. Please alert both your faculty and advisor.

We are updating the COVID-19 page on CCV's public <u>website</u>; you can always check there for the latest information. In addition, we will continue to monitor the guidance provided by State officials and the CDC and will adjust CCV protocols accordingly.

As always, please contact your CCV advisor with any questions about the fall semester or class registration.

In accordance with the CDC's recommendations and the Scott Administration's guidance towards public schools, CCV implemented universal indoor masking in early August. All students, faculty, and guests entering academic centers are required to wear a mask while indoors. Staff are required to wear masks inside when in the presence of others and/or outside their immediate workspace.

As we prepare for the start of the fall semester next week, I want to address some of the questions you may have:

- Will my classroom be set up for social distancing? Social distancing is no longer recommended by the VT Department of Health. Where possible, however, CCV has set up rooms to provide some extra spacing.
- What do I do if a student alerts me right before class that they are sick with COVID symptoms or have been exposed to someone who tested positive for COVID? If you are meeting in person, let your student know that they should not come to class. Signage at CCV entrances will instruct anyone who is experiencing cough, fever, or shortness of breath to refrain from entering the building. Encourage students to talk with their advisor and contact your coordinator of teaching and learning (CTL) to let them know about the situation.
- How should I treat an absence in my class when a student is unable to attend because they are sick with COVID symptoms? Please contact your CTL to talk through the specifics of the situation. However, we encourage faculty to extend flexibility with attendance policies during this time and to work with students, whenever possible, to develop a plan for completing missed class time and assignments.
- What do I do if a student in my class is not wearing a mask, or wearing a mask incorrectly? What can I ask? You may inform the student that mask-wearing is required and ask them to wear a mask properly. If the student doesn't have a mask, they are available at the front desk. You may not ask why a student isn't wearing a mask, but if a student discloses that they have a college-approved accommodation, you may ask to see the accommodation letter.
- What do I do if a student says that they have a condition that prevents them from having to wear a mask? Refer your student to an accessibility coordinator.
- What do I do if a student says they need a medical accommodation but do not have an accommodation letter from the College? Or if they have documentation from some other source? You can refer the student to an accessibility coordinator to follow

the process for requesting an accommodation. The student can and should be expected to wear a mask in the meantime.

- How will I know if a student has an approved accommodation? Students with college-approved accommodations will have an accommodation letter provided by their accessibility coordinator. The accommodation letter will outline the conditions required to maintain health and safety standards.
- What do I do if, even after being reminded of the masking protocols, a student in my class refuses to wear a mask? Like with any classroom disruption, its usually best to take a short break to allow the other students to leave the room while you address the disruption with them individually. You can explain to the student that mask-wearing is a safety requirement, and that failure to meet CCV's health and safety standards is considered a violation of the Student Code of Conduct. If the student still refuses to comply or you can't otherwise achieve resolution, you may cancel that day's class and report the Code of Conduct violation via the reporting form.
- How are decisions being made about mask accommodation requests? CCV considers
 all accommodation requests on a case-by-case basis. We must evaluate whether there is a
 medical or disability related need for the accommodation, and we must consider whether
 or not the accommodation can be provided without jeopardizing health and safety.
 Accommodations can only be approved if, along with additional measures and
 conditions, health and safety standards can be maintained.
- Can I ask a student why they aren't wearing a mask? You should not ask why a student is not wearing a mask. You may remind them of the masking protocols and ask them to wear a mask. If they disclose that they have a college-approved accommodation, you may ask to see the accommodation memo or you may contact the student's advisor.
- Can I ask a student if they are vaccinated? You may ask if someone is vaccinated but you may *NOT* ask to see their proof of vaccination or demand to know *why* they are not vaccinated. Furthermore, it is important to remember there are many reasons why someone may not be vaccinated.
- Will CCV students be required to be vaccinated? Vaccination continues to be the most effective way to protect ourselves and each other against the virus. It is our expectation that everyone in our learning community will be vaccinated if they are able to do so. However, as a non-residential college, we do not currently require proof of vaccination except in certain state-mandated programs, and we will continue that practice at this time.

• What is CCV doing to encourage students to get vaccinated? The College has launched a social norming campaign with students that includes text messages, emails, posters, and other communication to support student health and make CCV's vaccination expectations clear.

Dear CCV Faculty,

As President Joyce Judy shared in her message last Friday, CCV will be implementing a vaccination requirement for students beginning in January. All students taking in-person or hybrid classes at a CCV center will need to provide proof of vaccination or have an approved exemption before registering. We understand that you may have questions about this requirement as well as about other COVID-related issues. However, if you have additional questions not covered below, please reach out to your Coordinator of Teaching and Learning (CTL) or to our office.

Vaccination Questions

- Will all students be required to be vaccinated for COVID-19? All students taking in-person or hybrid classes at a CCV center in Spring and Summer 2022 must be vaccinated or have an approved exemption. Vaccinations for students taking only online based courses are encouraged but not required.
- Are CCV staff and faculty required to be vaccinated? As state employees and part of the VSC system, CCV staff and faculty must adhere to the guidelines established accordingly. COVID-19 vaccines are not currently required, but a federal mandate is pending.
- Why are we implementing this policy? Paired with other prevention measures, requiring vaccines will help the College reach the highest level of protection possible, reduce potential COVID exposures, limit teaching and learning disruptions, and safeguard our learning community.
- Will students still be required to wear masks in academic centers? At this time universal masking continues to be required for all students, faculty, and guests regardless of vaccination status. Masking also currently remains required for all staff when in the presence of others.
- What is considered vaccinated? If a student has received both shots in a two-shot sequence, or the Johnson & Johnson one shot, they are considered vaccinated.
- If a student receives a medical or religious exemption what guidelines must they follow when attending an in-person or hybrid class at a CCV academic center? Exempt students will follow all the same Vermont Department of Health guidelines and current CCV health protocols that are in place at the time. An exemption will not be publicly disclosed.
- If a student has not verified their vaccination status and is taking only online based courses, can they still access academic center resources for appointments, learning centers, and computer labs? Yes. All students, regardless of vaccination status, are welcome in CCV centers. Everyone will still need to follow the health protocols in place at the time.
- When will students learn about this requirement? Students will receive more detailed information about the process this week. On October 25th they will begin to receive secure links to enter their vaccination information.

COVID Protocol Questions

- If a student in my class reveals that they have COVID or someone close to them has COVID, who do I contact? A student may reach out directly to you to report a positive case or an exposure. Please keep this information confidential and share only on an "as needed" basis. This information should be reported to your CTL or a CCV staff member as soon as possible so they may file a COVID report. Please do NOT inform others in the class unless directed to do so by a CCV director or dean.
- What do I do if a student or students in my on-ground class are unable to attend because of COVID? Each situation is different, so it is important to talk with your CTL if you have questions or would like to discuss ideas. You may want to allow for greater flexibility around attendance and participation given that some students may miss class due to exposure, positive tests, or disruptions to their family's childcare or schooling.

Dear CCV Community,

Throughout the pandemic CCV has kept the wellbeing of our learning community at the forefront of our decision making, seeking to be both responsive and flexible to the evolving nature of COVID and its potential impacts.

In keeping with this goal, today I am announcing that, starting in January 2022, CCV will require that students enrolling in hybrid or in-person classes submit verification of vaccination prior to registering for the spring semester. Students enrolling in fully online classes will not be subject to this requirement.

This action will help limit teaching and learning disruptions, reduce potential exposures, and add yet another safeguard for our learning community members. We encourage all students to be vaccinated as soon as possible and have details on our web site about how students can access vaccines in their communities. Detailed information on the vaccination verification requirement will be shared with students next week, but below is an overview of the process.

- Students will verify their registration intentions and submit proof of vaccination through a secure web form provided by the College.
- Information links will be sent to students via CCV student email and text and will also be available on the CCV web site.
- Students may request a medical or religious exemption by filing an exemption request form (located in the information links) for review.
- Students taking fully online classes are exempt from the vaccination requirement, but are strongly encouraged to submit their vaccination records for future access.

I appreciate your efforts in maintaining COVID safety practices throughout the pandemic, and I am confident that this decision will help us have a productive, rewarding, and healthy spring semester.

Hello students,

As President Joyce Judy shared in her message last Friday, CCV will be implementing a vaccination requirement for students beginning in January. All students taking in-person or hybrid classes at a CCV center will need to provide proof of vaccination or have an approved exemption before registering. The week of October 25, a secure web form will be sent to all current students via CCV student email and text. The form will also made available in the portal. This is a cell phone camera friendly application designed for easy use. Easy-to-follow directions will be provided on the webform. We've addressed questions you may have about this requirement below.

I'm proud of the cooperation CCV students have demonstrated throughout the pandemic, maintaining vigilance and adhering to CCV protocols to keep each other safe. Please continue to do your part to support the health and safety of those in our academic centers and surrounding communities.

Frequently Asked Questions

Will all students be required to be vaccinated for COVID-19?

All students taking in-person or hybrid classes at a CCV center in Spring or Summer 2022 must be vaccinated or have an approved exemption. Vaccinations for students taking online based courses only are encouraged but not required.

Why are we implementing this policy?

Requiring vaccines, paired with other prevention measures, will help the College reach the highest level of protection possible, reduce potential COVID exposures, limit teaching and learning disruptions, and safeguard the learning community.

Is a booster shot also required?

Not at this time.

If I already had COVID-19 and recovered, do I still need to get a COVID-19 vaccine?

Yes, you will still be required to show proof of vaccination or receive an approved medical or religious exemption.

Will I still be required to wear masks in academic centers?

At this time universal masking continues to be required for all students, faculty, and guests regardless of vaccination status.

How do I submit proof of vaccination?

You will submit your proof of vaccination through a secure web form provided by the College. Links will be sent to all current students via CCV student email and text, and also made available in the portal. New students will receive the link with their application materials. This is a cell phone camera friendly application designed for easy use.

What if I have difficulty uploading my documentation?

Staff will be available to walk you through the use of the app as needed. You may also submit your vaccine card in-person at a CCV academic center.

Can I email CCV my documentation?

No. Verification cannot be accepted by email.

What if I can't locate my vaccination card?

For a lost vaccination card, there are three options:

- 1) Email vaxrecordrequest@vermont.gov, put "records request" in the subject line
- 2) Mail request to: Immunization Registry, 108 Cherry Street, Burlington, VT 05401
- 3) Call 888-688-4667 option #3

What is considered vaccinated?

If you have received both shots in a two-shot sequence (Pfizer or Moderna), or the Johnson & Johnson one shot, you are considered vaccinated.

Will I still be allowed to register if I have a vaccine scheduled but haven't had it yet?

Students may register for online or hybrid classes at any time. Once you have provided proof of vaccination, you may register for in-person or hybrid classes. In **very unique** circumstances, your advisor may be able to register you, however without providing vaccination status documentation by January 7, 2022, you are subject to removal (de-registration) from any pending in-person courses.

How can I apply for a medical or religious exemption?

The link you will receive via your student email and text will ask several questions and direct you to the exemption application form if requested. This form will also be found on the CCV web page under CCV COVID-19 information. Directions on where to submit exemption requests are on the form.

If I receive a medical or religious exemption what guidelines must I follow when attending an inperson or hybrid class at a CCV academic center?

Exempt students will follow all the same Vermont Department of Health guidelines and current CCV health protocols that are in place at the time. An exemption will not be publicly disclosed. On-going testing for exempted students is not currently required, but CCV is reviewing the directives on this issue carefully.

If I have not verified my vaccination status and am taking only online based courses, can I still access academic center resources for appointments, learning centers, and computer labs?

Yes. All students, regardless of vaccination status, are welcome in CCV centers. Everyone will still need to follow the health protocols in place at that time.

What happens when a class is scheduled to run-in person at a location that is not an academic center? Students who are taking classes at a high school, tech center, hospital, or other location that is not a CCV academic center will need to follow the requirements in place at that location. However, students will be required to be vaccinated if the class is held at a CCV center. This is true of both credit and non-credit classes.

COVID-19 Questions & Answers

- Are students in hybrid or in-person courses required to be vaccinated? Yes. Students were required to show proof of vaccination or receive a medical/religious exemption before being allowed to register for in-person or hybrid courses this spring semester. To date, fewer than 15 medical or religious exemptions have been approved.
- **Am I required to be vaccinated?** While vaccination is highly recommended, VSCS faculty and staff are not currently required to be vaccinated.
- Are students in my in-person class required to be masked? Am I required to be masked? Yes. Masks are currently required in CCV's academic centers, and to be properly worn should cover both the nose and mouth. Appropriate use of face masks or coverings is critical in minimizing risks to you and others near you. The Vermont Department of Health (VDoH) recommends wearing medical-grade masks; N95 or KN95 masks are preferrable. If you wear a cloth mask or gator, VDoH suggests using a surgical mask underneath the cloth.
- **Is social distancing required?** We recommend social distancing whenever possible, but it is not currently required.
- If a student in my class reveals that they have COVID or someone close to them has COVID, who do I contact? A student may reach out directly to you to report a positive case or an exposure. Please keep this information confidential and share only on an "as needed" basis. This information should be reported to your CTL or a CCV staff member as soon as possible so they may file a COVID report. Please do NOT inform others in the class unless directed to do so by a CCV director or dean.
- What do I do if a student in my class is unable to attend because of COVID? Each situation is different, so it is important to talk with your CTL about the situation. Given the substantial community spread of the Omicron variant, it is important to consider how you can be as flexible as possible in providing alternative means for students to remain current with assignments and class content.

- What if I or someone close to me contracts COVID? Reach out as soon as possible to your CTL so that they may work with you to support your needs and the needs of your students.
- Who is CCV's COVID Response Coordinator? Maria Basescu is CCV's point person for responding to COVID related reports. She is there to offer support and information to anyone in the CCV learning community through an initial wellness check and follow up. She tracks cases and helps direct individuals to the right internal and external resources as needed. Maria also assists in close contact notifications.
