### VITA Onsite Income Tax Assistance:

### AARP Volunteer Income Tax Assistance:

## Mortgage Assistance Now Available!

**Vermont Housing Finance Agency (VHFA)** is now accepting applications for assistance from Vermont homeowners who are behind on their housing expenses due to the COVID-19 pandemic. The [Vermont Homeowner Assistance Program](#) provides grants for eligible Vermont homeowners for missed payments on their mortgage, utilities, property taxes, and homeowner's or condominium association fees. The program is restricted to expenses related to a homeowner's primary home (other eligibility criteria also apply).

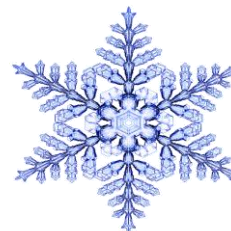
