The Free Legal Clinic's How-Tos!

Did you know that nearly every month, there is a free legal advice clinic for Vermonters to call into? The First Congregational Church UCC of Burlington is hosting a FREE Phone-In LEGAL CLINIC on Sunday, May 15, 2022. Their phone-in legal clinics are open to all in the community with any legal concern or question.

Here's what to do!

- All seeking legal assistance are asked to call (802) 862-5010 between noon and 1pm to request an appointment. All appointments will be between 1 and 3pm. (They cannot promise each caller an appointment but will do their best to serve as many people as they can.)
- A Legal Clinic volunteer will answer (or return) calls, asking for: contact information, name, phone number, email address, and the category of legal concern to be discussed.
- Callers reaching their answering machine, are asked to leave their name and phone number for a call back.
